2016 Annual Report



Project Resource Conference - June 14-16, 2016 - Atlanta, Georgia

Dear Colleagues and Friends,

While 2014 was a year of exploration and 2015 was a year of realization of hopes and dreams, 2016 turned out to be a year of stabilization.

The College for Bishops (CfB) is owned and operated by the House of Bishops (HOB), and your annual voluntary contributions continue to make a tremendous difference in our operating budget. The grant for this Triennium from General Convention helps subsidize the cost of the Living Our vows program for Dioceses that have elected a new Bishop. By canon, a newly-elected bishop must attend the required education and formation program approved by the House of Bishops. Tuitions and other gifts have added to our ability to have research projects and to provide new offerings such as The Leadership Institute and Project Resource 2.0.

Currently, over half of the HOB participates in the canonically required programs for newly-elected bishops, and a third will have participated in the new Project Resource sessions by May of this year. In addition, we had 13 couples attend the Orderly Transitions Conference for bishops who anticipate calling for an election in the coming three to five years. Readership of the materials from The Leadership Institute is at an all-time high, and we continue to have enrollment for the Residency and Coaching from around the Communion.

As you read this annual report which contains more details of our work this past year, think of a stabilized program and a robust Board which remains committed in 2017 to the mission of the College to provide quality formational and educational opportunities for bishops and others of this Church, as well as churches in communion with this Church.

By now you will have read that I am retiring in the spring of this year from my work for The Presiding Bishop through the Office of Pastoral Development. I will continue working for the College for the next two years. The Board and I think this will better ensure greater stabilization for the future as we seek to provide for continuing education for those elected to the episcopate and called by this Church to exercise a ministry of oversight.

Please enjoy this brief overview of the past year in the life of the College for Bishops.

PROJECT RESOURCE 2.0

Project Resource 2.0 is a collaborative effort sponsored by The Development Office of the Domestic and Foreign Missionary Society, The Episcopal Church Foundation, and the College for Bishops. Twenty-two Dioceses have participated in the first two sessions of this innovative and creative collaboration of the "best" this Church has to offer on the subject of raising people and resources. The next session will be held May 9-11, 2017 in Atlanta, Georgia. Ten Dioceses have signed up already, with five openings still available. Once a Diocesan team has participated, that Diocese may send individuals and congregations to future sessions. In 2018, there will be a special session for Dioceses that are particularly financially challenged, and scholarships will be offered on an as-needed basis. The date and location of this session will be announced at the March 2017 meeting of the House of Bishops. "We're changing the culture of resource development in our Church to be more fruitful for God's mission."

2016 COLLEGE FOR BISHOPS PROGRAM REPORT

90-Day Companion Program: assigns bishop companions to bishops-elect to assist them in the transitional period between election and consecration.

• 9 companion relationships were established in 2016

New Bishops and Spouses' Conference: assists the newly-elected bishops and their spouses in forming community and examining the transitional issues each is facing as he or she enters a new location, new expectations, and new responsibilities.

• The 2016 NBSPC was postponed due to a large snow storm

Living Our Vows Residency: provides opportunities for new bishops to gather in community, to reflect on the gifts, power and authority of the episcopate and to acquire resources to lead and serve dioceses effectively and faithfully.

• June 2016 – 22 participants (including participants from Canada and El Salvador)

Living Our Vows Peer Coaching: provides a three-year collegial relationship for new bishops that supports spiritual health and personal development and ultimately equips new bishops with skills for transformative leadership.

• 27 coaching relationships continued or began in 2016

Project Resource: provides teaching, focus and resources so that a team (one Bishop, two clergy, two lay leaders, one diocesan communications person) may return to their diocese equipped to teach and lead locally in areas of resource development.

• June 2016- 9 bishops, 20 clergy, 25 lay participated

The William and Sidney Sanders Conference on Orderly Transitions: provides opportunities for couples to prepare themselves and the dioceses for transition.

• November 2016–14 bishops and 9 spouses participated





RESEARCH

The College for Bishops' latest research project, "Fulfillment of Mutual Affection," is on the road. Conducted by Dr Marla Martin Hanley, this research explored the experiences of bishops and spouses after the episcopal election, particularly how both adults re-frame their individual life vocations during and after the transition. Dr Hanley invited participation through a qualitative and quantitative survey as well as individual in-depth interviews during 2015. The Spouse and Partner Planning Group has asked Marla to design a workshop for the spouse gathering at General Convention in Austin in 2018. She plans to highlight the blessings and challenges reported by participants at four chronological points: discerning the call, election and transition, settling in/bottoming out, and moving on. The focus of the workshop, however, will be brainstorming how, given the varieties of experiences, the spouse group can best support its members.
